**Agriculture Investments Co LTD** a California dba, herein represented by [REDACTED] President, hereby offers the following services to TEXAS HOLDINGS, INC, a Nevada, USA, corporation: **Silica Sand**, to be delivered as may be instructed by TEXAS HOLDINGS, INC.

The Services indicated herein shall conform to and abide by all local jurisdictional law, by USA law, and by U.S. STATE DEPARTMENT rules, regulations, and advisories.

For said services, TEXAS HOLDINGS, INC must provide **Agriculture Investments Co LTD** \$10 Million USD in pre-payment in the form of PROMISSORY NOTES issued by REHINO, LLC, a Texas, USA, corporation or equivalent (as may be selected by TEXAS HOLDINGS, INC) with total value of \$10 Million USD.
