**PRO-FORMA INVOICE**

Healthy Coffee International, Inc., a Colorado corporation, herein represented by its CEO, [REDACTED] [REDACTED] hereby offers the following products to TEXAS HOLDINGS, INC, a Nevada, USA, corporation:

Coffee products as maybe requested, to be delivered as may be instructed by TEXAS HOLDINGS, INC.

The Services indicated herein shall conform to and abide by all local jurisdictional law, by USA law, and by U.S. STATE DEPARTMENT rules, regulations, and advisories.

For said services, TEXAS HOLDINGS, INC must provide Healthy Coffee International, Inc. [\$150,000,000] One Hundred Million USD in pre-payment in the form of PROMISSORY NOTES issued by HOWSE SERVICES, INC., a Texas, USA, corporation or equivalent (as may be selected by TEXAS HOLDINGS, INC) with total value of [\$300,000,000] Three Hundred Million USD.

Healthy Coffee International, Inc. shall undertake to collect each PROMISSORY NOTE in USD bank deposit funds, or in any form that is acceptable to Healthy Coffee International, Inc. and to TEXAS HOLDINGS, INC.

Upon collection of each PROMISSORY NOTE, Healthy Coffee International, Inc. shall return 50% of proceeds to TEXAS HOLDINGS, INC as overpayment.

Services provided as indicated herein to TEXAS HOLDINGS, INC shall be charged at cost, verifiable by invoice from suppliers, plus a 50% override.

This pro-forma invoice shall be considered a contract to which Healthy Coffee International, Inc. is obligated upon receipt of the aforementioned PROMISSORY NOTES presented by TEXAS HOLDINGS, INC., but services shall only be performed as per proceeds from collection or use thereof, exchanging PROMISSORY NOTES into funds that Healthy Coffee International, Inc. may use, or using NOTES directly as payment instruments, to pay subcontractors or suppliers. Upon receipt of the aforementioned PROMISSORY NOTES by Healthy Coffee International, Inc., based on the ability of Healthy Coffee International, Inc. to provide items as stipulated herein, TEXAS HOLDINGS, INC is authorized by Healthy Coffee International, Inc. to resell the Services stipulated herein to other parties at the sole discretion of TEXAS HOLDINGS, INC.
