

ADVERTISING CREDITS

TEXAS HOLDINGS, INC uses COMMERCIAL CREDIT provided to TEXAS HOLDINGS, INC by U.S. PROFESIONALES DE EL SALVADOR, S.A. DE C.V. (“USPES”) to acquire UNIFORM ADVERTISING WEEK SERVICES (“UAWS”).

UAWS are designed to provide extra income to employees of firms that are registered with www.employeegold.info and to provide recovery of employee related expenses to the firms.

A firm may have employees use the “uniforms” or may have an employee charged with distributing the “uniforms” for use by others.

Distributing the “uniforms” to others might be accomplished by selling the “uniforms” to groups or to individuals, by donating the “uniforms” to charitable organizations, or by distributing them as “messages”.

The “uniforms” may be physical clothing or objects, or electronic advertisements, as may be arranged between the firm registered with www.employeegold.info and USPES.

When TEXAS HOLDINGS, INC provides payment for the COMMERCIAL CREDIT offered by USPES, USPES would provide payment for advertising to firms registered with www.employeegold.info.

In addition to payment to be received from USPES, upon request by a firm registered with www.employeegold.info, TEXAS HOLDINGS, INC could provide the firm access to COMMERCIAL CREDIT, of equal value to the expected payment, to issue PURCHASE ORDERS and REPURCHASE AGREEMENTS.

BUNDLES OF UAWS

Each package will be denominated as “**ADVERTISING CREDITS**”, will have a market value equal to the cost of the **UAWS** included in the package, and will be represented electronically by being registered with a specific designator in www.change2100.com/THIBMART/ under the heading “**ADVERTISING CREDITS**”.

Each registration of **ADVERTISING CREDITS** will show a designated owner and will be password protected.

Once the **ADVERTISING CREDITS** have been resold to **TEXAS HOLDINGS, INC** and full payment has been received through the **REPURCHASE AGREEMENT**, **TEXAS HOLDINGS, INC** will be registered as the owner and may resell the **ADVERTISING CREDITS** through subsequent transactions.
