Diamond Seven Ranch Inc herewith provides, along with this PRO-FORMA INVOICE a letter of good standing with a commercial bank.

In the event this PRO-FORMA INVOICE is accepted, TEXAS HOLDINGS, INC is to provide Diamond Seven Ranch Inc \$250,000,000.00 Million UNITED STATES DOLLARS, as pre-payment for delivery of ITEMS.

All uses of the ADVERTISING CREDIT PROMISSORY NOTES by Diamond Seven Ranch Inc are subject to pre-approval by TEXAS HOLDINGS, INC and any non-pre-approved use may, at the sole discretion of TEXAS HOLDINGS, INC, immediately invalidate and void said ADVERTISING CREDIT PROMISSORY NOTES, but without affecting or eliminating the obligations of Diamond Seven Ranch Inc related to this PRO-FORMA INVOICE.

Upon receipt by Diamond Seven Ranch Inc of pre-payment made by TEXAS HOLDINGS, INC, as stipulated herein, based on this declared ability of Diamond Seven Ranch Inc to deliver ITEMS as stipulated, TEXAS HOLDINGS, INC is authorized by Diamond Seven Ranch Inc to resell ITEMS to other parties at the sole discretion of TEXAS HOLDINGS, INC.
