The following is a template used to contract with entities that wish to be capitalized by FIDES and clause 23 shows their agreement to accept FIDES IBOE as well as other instruments (such as MTN); which contract having been accepted by entities in Europe, Africa, South America, and Australia provides evidence of the international acceptability and thus international legal precedent pertaining to the “Law of Nations”.

Additionally, officers of FIDES have personal knowledge of uses of IBOE by which foreclosures on real estate by two major USA banks in two separate States were renegotiated, one of which renegotiations was accomplished between attorneys without involving a local Court and the other by a local Court order; and, of one Federal Court Case, a lawsuit by the U.S. SEC, wherein payment with an IBOE was discussed and explained by a defendant without dissent by the SEC attorneys and without any objection being raised by the Judge.
