FUNDS

- ONLY UNITED STATES DOLLARS DEPOSITS...
- ...WITH FIDES GESTION FINANCIERA, S.A. DE C.V...
- MAY BE USED TO TRADE USING THE TEXAS HOLDINGS, INC.

ACPN & IBOE

- UNITED STATES DOLLARS DEPOSITS WITH FIDES MAY BE MADE WITH ACPN & IBOE

SELECT TRADER

- AN ENTITY THAT HAS A DEPOSIT WITH FIDES MAY SELECT AN INDEPENDENT CONTRACTOR TO BE A TRADER...
- ...FROM THE LIST OF RESUMES...

- ...AND PROVIDE THE SELECTED CONTRACTOR ACCESS TO TRADE...
- ...USING ACPN & IBOE DEPOSITED WITH FIDES GESTION FINANCIERA, S.A. DE C.V...
- ...DOCUMENTED AS MAY BE REQUIRED BY FIDES

WORK WITH TRADER

- PROVIDE REFERRALS TO TRADER...
- FOR ENTITIES THAT WOULD BENEFIT BY MAKING PURCHASES OF ANYTHING AND RECEIVE 100% REBATES...
- IN THE FORM OF UNITED STATES DOLLARS ACPN & IBOE...
- WHICH MAY BE USED...
- ...TO MAKE PAYMENTS ON DEBTS...
- ...TO NEGOTIATE NEW TRANSACTIONS...
- ...TO DEPOSIT WITH FIDES AND USED TO ACCRUE PROFITS THROUGH THE SERVICES OF THE TRADER TO SEEK INVESTMENTS AND/OR TO ENGAGE IN BUY/SELL TRANSACTIONS

BUY/SELL TRANSACTIONS

- A TRADER MAY NEGOTIATE WITH A BUYER, WITH A SUPPLIER, AND WITH TEXAS HOLDINGS, INC...
- ...TO ARRANGE TRANSACTIONS THAT ARE A WIN-WIN-WIN...
- ...WITH PROFITS TO BE DISTRIBUTED AS PER REPURCHASE AGREEMENTS THAT ARE RELATED TO ACPN & IBOE DEPOSITED WITH FIDES GESTION FINANCIERA, S.A. DE C.V...
- ...AND AS MAY OTHERWISE BE APPROVED BY TEXAS HOLDINGS, INC AND BY FIDES

AIRPLANE EXAMPLE

- A BUYER MAY AGREE TO PAY \$80 MILLION UNITED STATES DOLLARS FOR ONE OR MORE AIRPLANES...
- ...AND RECEIVE ACPN & IBOE VALUED AT \$80 MILLION UNITED STATES DOLLARS AS A REBATE...
- ...A SUPPLIER MAY OFFER TO PROVIDE THE AIRPLANES FOR \$76 MILLION UNITED STATES DOLLARS...
- ...TEXAS HOLDINGS, INC AND FIDES GESTION FINANCIERA MAY APPROVE THE TRANSACTION...
- ...MAKING THE PROFIT \$4 MILLION UNITED STATES DOLLARS

TRUCK EXAMPLE

- A BUYER MAY AGREE TO BUY SEVERAL TRUCKS FOR \$1 MILLION UNITED STATES DOLLARS...
- ...AND RECEIVE ACPN & IBOE VALUED AT \$1 MILLION UNITED STATES DOLLARS AS A REBATE...
- A SUPPLIER MAY AGREE TO SELL THE TRUCKS FOR \$950,000 UNITED STATES DOLLARS...
- ...TEXAS HOLDINGS, INC AND FIDES GESTION FINANCIERA MAY APPROVE THE TRANSACTION...
- ...MAKING THE PROFIT \$50,000 UNITED STATES DOLLARS

CAR CLUB EXAMPLE

- A GROUP MAY BAND TOGETHER TO FORM A CAR BUYING CLUB...
- THE GROUP MAY AGREE TO BUY SEVERAL CARS TOTALING \$1 MILLION UNITED STATES DOLLARS IN VALUE...
- ...AND RECEIVE ACPN & IBOE VALUED AT \$1 MILLION UNITED STATES DOLLARS AS A REBATE...
- ...A SUPPLIER MAY AGREE TO SELL THE CARS FOR \$950,000 UNITED STATES DOLLARS...
- ...TEXAS HOLDINGS, INC AND FIDES GESTION FINANCIERA MAY APPROVE THE TRANSACTION...
- ...MAKING THE PROFIT \$50,000 UNITED STATES DOLLARS

GOLD EXAMPLE

- A CENTRAL BANK MAY WISH TO BUY \$100 MILLION UNITED STATES DOLLARS IN VALUE OF GOLD TO BE HELD FOR RESERVES...
- ...BUT THE CENTRAL BANK DOES NOT HAVE THE \$100 MILLION UNITED STATES DOLLARS...
- ...THE TRADER MAY USE YOUR ACPN & IBOE TO PREPAY FUTURE TAXES THAT YOU MIGHT OWE BY DOING BUSINESS WITHIN THAT JURISDICTION...
- ...THE GOVERNMENT MAY ISSUE A RECEIPT IN THE FORM OF A TAX CREDIT...

- ...THE TAX CREDIT MAY BE DEPOSITED ALONG WITH THE ACPN & IBOE WITH FIDES GESTION FINANCIERA, S.A. DE C.V...
- ...THE TRADER MAY UNDERTAKE TRANSACTIONS WITH THESE TO PROVIDE PROFITS THROUGH BANK CAPITALIZATION AS MAY BE APPROVED BY THE CENTRAL BANK...

- THE GOLD COULD BE PURCHASED WITH PROFITS AND NEGOTIATED PROFITS COULD BE DISTRIBUTED BY THE TRADER AS PER REPURCHASE AGREEMENTS AND AS MAY OTHERWISE BE AUTHORIZED BY TEXAS HOLDINGS, INC
- THE TAX CREDITS COULD BE RETURNED WITHOUT COLLECTION TO THE GOVERNMENT AND THE ACPN & IBOE RETURNED TO YOU...
- ADDITIONAL PROFITS COULD BE AVAILABLE FOR DISTRIBUTION FROM DISCOUNTS PROVIDED BY A GOLD SUPPLIER

- A LARGE ENERGY CONSUMER MAY PURCHASE O&G...
