Mr. Saunders grew up in a small town in Western Canada and immigrated to the United States in 2010.

Mr. Saunders first business was initiated while in high school in the very early 1990s. He partnered with his father and provided an advertising service that reached the clientele of video store chains. As example, he was instrumental in negotiating large deals between Canada's second largest railway and their scrap recycled rail and rail car wheels to a top Korean steel company's purchasing group.

In 2010, Mr. Saunders liquidated his positions and legally immigrated to the USA. While counting with his business, as he was now located in the USA, he took some time to go back to school and concentrated on his interest of health and body. As a hobby he became qualified as a personal trainer.

In 2011, Mr. Saunders applied to a small university to further understand the body and neuro processing and the psychological relationship to the physiological uptake and outputs. While continuing in his day to day business, Mr. Saunders qualified and was given a PhDc (Provisional Doctorate) in Psychoneurology.
