SUPPLIERS CAN BE BUYERS

- SUPPLIERS THAT HAVE ISSUED PRO-FORMA INVOICES TO SELL ITEMS TO TEXAS HOLDINGS, INC MAY USE COMMERCIAL CREDIT TO BUY THE ITEMS THEY OFFER IN THE INVOICES
- SUPPLIERS MAY USE COMMERCIAL CREDIT TO BUY ITEMS THEY WISH TO SELL TO OTHER ENTITIES
- SUPPLIERS MAY USE COMMERCIAL CREDIT TO BUY ITEMS THEY NEED FOR THEMSELVES

EVERY PURCHASING DEPARTMENT CAN BE A BUYER

- SMALL AND LARGE... EVERY BUSINESS HAS STAFF THAT PURCHASE ITEMS FOR THE BUSINESS
- BEING ABLE TO PROFIT BY BUYING TURNS PURCHASING INTO A PROFIT CENTER INSTEAD OF A CASH DRAIN

GOVERNMENTAL ENTITIES CAN BE BUYERS

- EVERY GOVERNMENTAL ENTITY PURCHASES ITEMS
- IF THEY ARE NOT ALLOWED TO PROFIT THROUGH EXPENDITURES BY LAW...
- ...AN INDEPENDENT CONTRACTOR MAY PERFORM THE FUNCTION FOR THEM AND PASS ON THE PROFITS THROUGH RESELLING THE ITEMS THEY NEED AND ACCEPT AS PAYMENT TAX CREDITS ISSUED AS PER TEXAS HOLDINGS, INC PROTOCOLS
