## **REPURCHASE AGREEMENT**

A REPURCHASE AGREEMENT should be on Corporate or Business Letterhead.

It should be addressed to a specific TEXAS HOLDINGS, INC BUSINESS MART CALL CENTER.

It should specify the ADVERTISING CREDITS that you wish to have purchased from your business, at full market value.

It should acknowledge that payment for the REPURCHASE, in funds as specified in the REPURCHASE AGREEMENT, will take place ONLY after Buyers that your business has referred have purchased sufficient ADVERTISING CREDITS through the CENTER, from TEXAS HOLDINGS, INC, at 25% of their market value, to where the CENTER income from said purchases equals 200% of the price at which the REPURCHASE AGREEMENT requests that the ADVERTISING CREDITS are to be repurchased from the business.

## It should include the following paragraph:

In derogation of applicable provisions of international treaties or domestic laws, all parties hereto hereby severally solemnly state that they have irrevocably accepted (i) that the laws of the State of Texas, United States of America, apply exclusively, having absolute precedence over any other law of any other jurisdiction, and (ii) to elect as exclusive jurisdiction and venue, which hold respectively absolute precedence over any other jurisdiction and venue whatsoever, as per the rules and regulations thereof, the Courts of Galveston County, Texas, United States of America.

Payment should be specified as being satisfied when you receive the total amount of the REPURCHASE AGREEMENT, provided by the CENTER, deposited in account coordinates that you specify.

It should be signed by an authorized party and notarized, witnessed, or sealed.
