# ISSUE A PURCHASE ORDER

- ISSUE YOUR OWN PURCHASE ORDER...
- ...TO AN ENTITY THAT IS REGISTERED WITH [www.employeegold.info](http://www.employeegold.info) ...
- ...NEGOTIATING TERMS AND CONDITIONS WITH THAT ENTITY...
- ...ASKING TO PURCHASE ANY ITEM THAT IS LEGITIMATELY SOLD IN THE WORLD.

# PAY AND GET A REBATE

- YOU MAY MAKE PAYMENT AND GET A REBATE AS MAY BE NEGOTIATED WITH THE ENTITY YOU ISSUE THE PURCHASE ORDER TO...
- ...REDUCING YOUR COST DOWN TO POSSIBLY A NET- ZERO AMOUNT!
- THE REBATE WOULD BE DEPOSITED IN AN ACCOUNT THAT YOU MAY ESTABLISH WITH FIDES GESTION FINANCIERA, S.A. DE C.V. ("FIDES")

# OR, RECEIVE A REBATE AND MAKE PAYMENT

- YOU MAY NEGOTIATE WITH THE ENTITY THAT YOU ISSUE THE PURCHASE ORDER TO...
- ...SO THAT YOU ARE PROVIDED THE REBATE BEFORE YOU MAKE PAYMENT...
- ...AND USE THE REBATE TO MAKE PAYMENT...
- ...REDUCING YOUR OUT-OF-POCKET POSSIBLY DOWN TO A ZERO AMOUNT!

# IMMEDIATE PROFIT FROM PURCHASING

- TO ACCOMPANY EACH PURCHASE ORDER...
- ...A SEPARATE PURCHASE OF "SUPER UAWS" THROUGH AN INDEPENDENT CONTRACTOR MUST BE NEGOTIATED...
