ZCASH UNITS, CHIPS UNITS

- ▶ U.S. PROFESIONALES DE EL SALVADOR, S.A. DE C.V...
- ▶ ...MAY REGISTER VALUE OF ACPN RECEIVED AS PAYMENT FOR UAWS...
-SUBDIVIDED INTO LEDGER ENTRIES DENOMINATED AS "ZCASH UNITS" AND "CHIPS UNITS".
- > ZCASH UNITS ARE VALUED AT \$2 UNITED STATES DOLLARS EACH.
- ► CHIPS UNITS ARE VALUED AT \$1 UNITED STATES DOLLARS EACH.
- ► WHEN ACPN VALUE IS THUS SUBDIVIDED...
- ▶ ...FOR EACH ZCASH UNIT REGISTERED IN A ZCASH LEDGER...
- ▶ ...TWO CHIPS UNITS WILL BE REGISTERED IN A CHIPS LEDGER.

NON-DEPLETION OF VALUE

- ► WHEN AN UNDERLYING ACPN IS COLLECTED...

- ▶ ...WORKING WITH A TEXAS HOLDINGS, INC. BUSINESS MART CALL CENTER...
- …AND "PAY-IT-FORWARD"…
- ▶ ...BY ACQUIRING FIVE UAWS...
- ...FOR ADVERTISING FOR SUPPLIERS...
- ▶ ...REGISTERED WITH TEXAS HOLDINGS, INC...
- ► EACH LEDGER THUS ASSIGNED...

- ...WITH VALUE AND OWNERSHIP INFORMATION...

EXEMPTION

- ► TEXAS HOLDINGS, INC BUSINESS MART CALL CENTERS...
- …AND INDEPENDENT CONTRACTORS…
- ▶ ...REGISTERED WITH TEXAS HOLDINGS, INC...
-MAY REQUEST ONE ZCASH LEDGER AND ONE CHIPS LEDGER CREATION AND ASSIGNMENT...
- ▶ ...WITH NO "PAY-IT-FORWARD" REQUIREMENT.

INITIAL REGISTRATION

- > ZCASH UNITS AND CHIPS UNITS CREATED BY SUBDIVISION OF AN ACPN...
- …ARE REGISTERED IN LEDGERS OF U.S. PROFESIONALES DE EL SALVADOR, S.A DE C.V...
- ...HEREINAFTER REFERRED TO AS "INITIAL ZCASH LEDGER" AND "INITIAL CHIPS LEDGER"

ZCASH UNITS AND CHIPS UNITS TRANSFER WHEN INITIALLY REGISTERED.

- ▶ WHEN AN ACPN IS ACCEPTED AS PAYMENT FOR UAWS...
- ▶ ...THROUGH PROMOTION BY AN INDEPENDENT CONTRACTOR...

- ...OR BY NEGOTIATING WITH OTHER PARTIES TO OBTAIN ACPN ALREADY ISSUED...
- ▶ ...SUBJECT TO APPROVAL BY U.S. PROFESIONALES DE EL SALVADOR, S.A. DE C.V...
- ► ...AS MAY BE ARRANGED THROUGH INDEPENDENT CONTRACTORS...
- ▶ ...WORKING WITH TEXAS HOLDINGS, INC. BUSINESS MART CALL CENTERS.

ZCASH UNITS ACQUISITION THROUGH WORK

- ► TEXAS HOLDINGS, INC. BUSINESS MART CALL CENTERS...
- …AND INDEPENDENT CONTRACTORS…
- ► ...MAY OPT TO COLLECT COMPENSATION IN EQUAL VALUE ZCASH...
- …INSTEAD OF IN OTHER FUNDS.

USING ZCASH UNITS FOR BUSINESS

- ZCASH UNITS MAY BE TRANSFERRED FROM ONE ZCASH LEDGER TO ANOTHER...
- ▶ ...AS MAY BE NEGOTIATED BETWEEN ENTITIES THAT HAVE ZCASH LEDGERS.
- EACH TRANSFER WILL REQUIRE A "PAY-IT-FORWARD" PURCHASE OF ONE UAWS...
- ▶ ...AS MAY BE ARRANGED THROUGH AN INDEPENDENT CONTRACTOR...
- ▶ ...WORKING WITH A TEXAS HOLDINGS, INC. BUSINESS MART CALL CENTER.

BONUS FOR DOING BUSINESS WITH ZCASH UNITS

- WHEN ZCASH UNITS ARE TRANSFERRED FROM ONE ZCASH LEDGER TO ANOTHER...
- ▶ ...EQUAL VALUE CHIPS UNITS WILL BE TRANSFERRED FROM THE INTIAL LEDGER...

- EACH TRANSFER WILL REQUIRE A "PAY-IT-FORWARD" PURCHASE OF ONE UAWS...
- ▶ ...AS MAY BE ARRANGED THROUGH AN INDEPENDENT CONTRACTOR...
- ▶ ...WORKING WITH A TEXAS HOLDINGS, INC. BUSINESS MART CALL CENTER.

CLEARING OF ZCASH UNITS

- ZCASH UNITS MAY BE CLEARED BY ISSUING A PURCHASE ORDER WITH THE "FUNDS FOR CLEARING OF ZCASH UNITS" AS THE ITEM ORDERED...

- …AND SATISFYING THE REPURCHASE AGREEMENT.
- ► THIS WILL REQUIRE A "PAY-IT-FORWARD" PURCHASE OF FIVE UAWS FOR EACH 500,000 ZCASH UNITS OR PORTION THEREOF THAT ARE TO BE CLEARED.
- ▶ WHEN FUNDS FOR CLEARING ARE THUS PROVIDED...
- ▶ ...THE ZCASH UNITS WILL BE TAKEN OFF THE BOOKS...
- ▶ A NUMBER OF CHIPS UNITS EQUAL TO TWICE THE AMOUNT OF THE CLEARED ZCASH UNITS...
